WHEREAS, it is necessary and appropriate for the East Rutherford Borough Council to discuss certain matters in a meeting not open to the public consistent with <u>N.J.S.A.</u> 10:4-12(b).

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of East Rutherford, Bergen County, New Jersey as follows:

- 1. The East Rutherford Borough Council shall immediately hold an Executive Session, from which the public shall be excluded.
- 2. The general nature of the subjects discussed at said Executive Session shall be confidential security issues
- 3. The Minutes of the Executive Session shall be made available for disclosure to the public, consistent with N.J.S.A. 10:4-13, when the items which are the subject of the closed session discussion are resolved and the reason for confidentiality no longer exists.
