Frank Recanati would like to further discuss property maintenance and code enforcement as well as the idea of possibly expanding Rocco's role with the borough. The town needs more code enforcers that want to work. He also discussed the outdoor seating at Elia. His office and Engineer Beckmeyer have concerns.
