Mayor Cassella asked any of the Council if they had a report for the work meeting.

Councilman Homaychak stated that he is looking into why the old website is not working. Paul DeRosa showed the Council a sample of a sticker that they place on cans that do not recycle. Councilman Ravettine stated that he may have some ideas to also contribute.

Mayor Cassella asked Rick Arango of Remington & Vernick for his report:

- 1. The Civic Center generator has been installed. The contractor hit an electrical conduit but it has been repaired. They are waiting for the cabinet to be supplied by PSE&G.
- 2. The VFW room asbestos removal is complete.

3. Currently working on the Carlton Avenue Firehouse generator. They need to perform a different analysis on the electric at the building.

Liz Wilson, EIT from Remington & Vernick, reported on the following:

- 1. The fieldwork is completed for 2 Carlton Avenue. The remaining items are paperwork and reports, then Green Acres can release the rest of the funding.
- 2. The vapor extraction system at the DPW is operational; however the ground water is still testing high for benzene. The next report is due in March.
- 3. The preliminary report for 10 Morton Street will be complete prior to the next meeting.

Engineer Beckmeyer gave the following report:

1. Application #2 was submitted by Sanzari in the amount of \$55,860.00 was submitted for the Riggin Field project:
