## MINUTES OF THE BOROUGH OF EAST RUTHERFORD MAYOR & COUNCIL SPECIAL MEETING HELD ON JUNE 9, 2021 AT ONE EVERETT PLACE

SPECIAL MEETING WAS CALLED TO ORDER BY MAYOR LAHULLIER AT 6:07PM. FLAG SALUTE WAS HELD AND THE FOLLOWING OPEN PUBLIC MEETING STATEMENT WAS READ:

This meeting is a Special Meeting of the Mayor and Council of the Borough of East Rutherford and is called pursuant to the provisions of the Open Public Meetings Law. Mayor Lahullier turned the meeting over to Engineer Beckmeyer to explain the property:

#### Engineer Beckmeyer:

Tonight we are here for the East Rutherford NJDEP Green Acres Urban Park 2021 Grant public hearing. The letter of intent to apply was submitted on April 11, 2021 Open Space Trust Fund County of Bergen in Hackensack, and the submission was on May 14, 2021. The location of the property is Block 94, Lot 3 otherwise known as 231 Hackensack Street East Rutherford. On the easel is the tax map block and lot. The proposed site contains a single family historical house it is located on a property approximately 0.48 acres.

The Richard Outwater House, is a Dutch Colonial Stone House that was built in 1821. The land originally consisted of many acres; parcels were sold off over time, leaving just under one-half acre and the house at 231 Hackensack Street. The house is bordered by Hackensack Street to the southeast, Union Avenue to the southwest, Summer Street to the northwest, and Orchard Street to the northeast. It consists of 6 bedroom, 2 & 1/2 bathrooms, and 3 common rooms including a kitchen. The neighborhood is a mix of residential homes, apartments and townhouses, light industrial, retail businesses, and a branch of the Federal Reserve.

The house was added to the National and New Jersey Register of Historic places in 1983 as a Thematic Nomination of early Stone Houses of Bergen County. Erie RR Main Line Historic District and the HX Drawbridge are also listed on the historic Registers, however the Outwater House is the only building of any type in East Rutherford Borough on the Register. The Structure and grounds are falling into obvious disrepair; exterior wood siding on second floor and windows require restoration/painting; stone wall near sidewalk is decaying; vegetation is overgrown onto sidewalks; historic aspects of interior spaces, such as fireplaces, are not being maintained; trees surrounding the house are overgrown, impaction roof integrity. Recently, the estate with owns the property listed it for sale for \$1,900,000, more than twice its asking price. There is concern the property could be developed, placing additional residential units on a lot which has great potential for open space for our residents. Borough plans to purchase the property, maintain it, and protect it from further deterioration. In a future project, the house will be renovated with historical aspects of the house preserved, as feasible. Protecting, renovating and preserving the house (to the extent possible) will maintain a connection to East Rutherford's past and provide a sense of place and history for residents.

The long-term plan is to provide space for East Rutherford Historical Society office and events, and civic groups (senior citizens, scout troops, etc.) to meet and hold events. The grounds will also be improved and maintained for enjoyment by residents by adding native plantings to the existing trees, and installing benches for respite. The house is a short walk from Riggins field, which is across the street on the far southeast corner. Residents use the empty lot next door to the Outwater House as parking for Riggins Field, where they enjoy active recreation. Creating green spaces which adjoin or are within a short walk of each other is a priority for East Rutherford as it provides its residents with diverse opportunities for recreation. The grounds of the house add

passive recreation to the area, as well as convenience for residents as different activities (scout, sports and games) may be located within walking distance.

The Borough plans to make future renovations to address access. The house is not currently ADA compliant; an ADA compliant ramp will provide access to the first-floor where gender-neutral bathroom will be made ADA compliant. A parking area will be designed for easy flow and safety of pedestrians on the property.

The owners appear willing to sell since they discussed a possible sale to the Borough and then listed the property for sale. Currently, the Borough is attempting to reach the owners (estate) to negotiate a purchase; we anticipate negotiations may be protracted. Anticipated close time frame is mid-2022.

The Borough has not received any views, opinions, or arguments of opposition. The house, once renovated, will be compatible with use as office and civic space, and the land as passive recreation space. Hackensack Avenue is a well-traveled road, however the proposed uses would not add significant traffic to the area. A zoning change will be required, however the Borough does not anticipate any issues. Possible adverse impacts could include noise from people entering/exiting the building and groups meeting outside.

We also checked in the Master Plans of Bergen County there are two items of Bergen County Master Plan. On page 54, The County of Bergen seeks to appropriately balance the types of open space we have particularly between active and passive recreation. Diverse and balanced facilities will ensure almost everyone will find something to do or enjoy in the park system.

East Rutherford Master Plan, on page 58, East Rutherford is "very underserved" municipality for publicly available open land. This would add to East Rutherford with concerns of Bergen County Master Plan.

NJ State Development and Redevelopment Plan Statewide Goals and Policies

Policy Category 9- Historic, Cultural and Scenic Resources:

Pg. 144 Protect, enhance, and where appropriate rehabilitate historic, cultural and scenic resources by identifying, evaluating and registering significant historic, cultural and scenic landscapes, districts, structures, buildings, objects and sites and ensuring that new growth and development is compatible and with historic, cultural and scenic values.

Policy Category 12- Open Lands and Natural Systems:

Pg. 152 Sub-policy 5: Adequate Recreational Facilities where appropriate for the year-round enjoyment and health of residents and tourists.

Pg. 154 Sub-policy 13: Locate recreational facilities and open space as close as possible to the populations they serve, taking into account the nature of the recreational facility or open space.

We also have a letter memorandum for Phillips Preiss Borough Planner stating:

Acquisition of the Richard Kip-Outwater House through the grant program would allow protection of this rare historic resource in the Borough and advance the goals and objectives of the draft Master Plan.

With that I believe that will cover our Master Plan with the Borough.
