NOTICE OF LIEN SALE OF PROPERTY FOR NON-PAYMENT OF TAXES,
ASSESSMENTS AND OTHER MUNICIPAL CHARGES**

Notice is hereby given that I, Linda C. Ramsaier, Tax Collector of the Borough of East Rutherford in the County of Bergen, State of New Jersey, shall on Tuesday, June 16, 2015 at 10:00 a.m. in the Municipal Building, One Everett Place, East Rutherford, N.J. expose for lien sale and sell the several tracts and parcels of land on which taxes and/or other municipal charges remain unpaid for the year 2014 and prior subject to N.J.S.A.54: 5 et seq. Said properties will be sold subject to redemption at the lowest interest rate, but in no case shall exceed 18% per annum. Payment for liens purchased shall be made via cash, money order or certified check at the conclusion of the sale. IF YOU KNOW SOMEONE ON THIS LIST WHO IS ACTIVELY SERVING IN THE MILITARY, PLEASE CONTACT THE TAX COLLECTOR.

Industrial properties may be subject to the Spill Compensation and Control Act (N.J.S.A.58:10-23.11 et seq.), the Water Pollution Control Act (N.J. S.A.58:10-A1-1 et. seq.), the Industrial Site Recovery Act (N.J.S.A.13:1K-6 et. seq.). In addition, the municipality is precluded from issuing a tax sale certificate to any prospective purchaser that may be in any way connected to the prior owner or operator of the site.
